Change Description

By changing the design of the PCB for the stated camera models it was possible to improve the EMC emission behavior of the cameras so that they now conform to the standards IEC 61000-6-3, CISPR 32 Class B and FCC Part 15 Subpart B Class B. Before, they only conformed to the standards IEC 61000-6-4, CISPR 32 Class A and FCC Part 15 Subpart B Class A.
