Reason for Change

In march 2018 Basler introduced the Basler MED ace series with originally 12 camera models with USB3 and GigE Interface. Over the last 6 years we expanded the feature set continuously and increased the range of MED ace series to 22 camera models.

When introducing this camera series one aspect was the production, distribution and service under DIN EN ISO 13485:2016 and a second aspect was to provide special features to these special market requirements. With the introduction of the DIN EN ISO 13485:2016 quality management system, we saw the advantage of the reduced effort involved in integrating the camera and subsequent certification of customer systems in accordance with DIN EN ISO 13485:2016.

As Basler we want to offer products to our customers which have the best price performance ratio, are reliable and easy to integrate.

When we analyzed the feedback from our customers, we came to the conclusion that production, distribution and service in accordance with DIN EN ISO 13485:2016 did not bring as much benefit to our customers as originally expected.

To keep these products in a good price performance ratio Basler decided to not produce, distribute and service these cameras under DIN EN ISO 13485:2016 any longer.

MED Dust protection+ feature: will remain unchanged.

<u>Traceability:</u> cannot be guaranteed 100% to the lowest level of components anymore. But we still have the good traceability of our DIN EN ISO 9001:2015 processes.

But will still publish product change notifications for changes which affect form, fit or function.
