## **Confirmation of RoHS Compliance for Basler Companion Products**

### **Product Group: Lenses - S-Mount / M12 - 1/2" (also suitable for 1/1.8")**

Dear Sir or Madam,

Restriction of the use of certain Hazardous Substances (RoHS 1 and RoHS 2) is a pan-European environmental directive (**2002/95/EC** RoHS 1 and **2011/65/EU** RoHS 2) targeted at reducing hazardous materials used in the production of electronic devices. This directive bans placement on the European market of electrical and electronic equipment containing lead (Pb), mercury (Hg), cadmium (Cd) hexavalent chromium (Cr(VI)), polybrominated biphenyls (PBB) and polybrominated diphenylethers (PBDE). This ban is effective as of July 1, 2006 (RoHS 1) and January 2, 2013 (RoHS 2).

The EU commission has published a new Directive (**EU**) **2015/863** (RoHS 3) to amend Annex II to Directive 2011/65/EU (RoHS 2) to add the following 4 phthalates onto the list of restricted substances: Bis(2-Ethylhexyl) phthalate (DEHP), Benzyl butyl phthalate (BBP), Dibutyl phthalate (DBP), Diisobutyl phthalate (DIBP).
